Fellowship Village Pet Visitation Policy



Fellowship Village administration periodically reviews the facility policies and last year reviewed the pet visitation guidelines. The majority of our residents enjoy seeing pets and to ensure the safe oversight and management of animals that enter our facility we are reposting the policy. Please share this information with other family/friends who might wish to bring a pet to visit.

Fellowship Village will allow a **personal pet** (non-service or pet therapy certified animals) visitation in the facility lobby (first door on the left when entering the building) in accordance with the following guidelines:

- Nursing staff will determine if a family pet visit is permitted in the facility and if the resident's condition allows in accordance with the guidelines put forth in the Animal Visitation policy
- Personal pet visitation may occur outdoors or in front lounge (room across from the front offices)
- Visits are limited to dogs or cats and they must meet criteria established by Infection Prevention
- The pet is certified in good health by the pet's veterinarian
- Animals must be healthy and current with immunizations, including rabies vaccinations and others required in the state in which the healthcare facility is located. ***The facility must have a copy of the current immunizations in order to visit***
- The pet must be visibly clean and well groomed with no evidence of skin disease, eye drainage, open sores, etc
- Dog nails should be trimmed short with no rough edges
- The pet is contained in a pet carrier or on a leash during transport from the entrance to lobby area
- The pet's adult owner/family member stays with the pet at all times
- All individuals in direct contact with the pet must wash their hands with soap and water afterwards
- The animal must not be a current resident of an animal shelter, pound, or similar facility
- Exceptions may be granted on an individual basis by the Manager of Infection Prevention
