Fellowship Village COVID Update

Hello Fellowship Families! I hope that fall's arrival finds you well. We are ex-

cited about some changes to regulations that have been shared us this week, and wanted to make you aware.

Screening staff and visitors is no longer required. Therefore, the screening kiosk by the front door has been removed. However, we do ask that you refrain from visiting if you have any symptoms of COVID or any other illness including fever, cough, runny nose, etc.

Making requirements will change based on the county transmission level. These levels are checked weekly and we will have a sign on our front door of the transmission level and corresponding requirement regarding masking. When in high transmission levels, masking will be required.

Masking will also be required if we were to have any positive staff or residents, putting us into outbreak status. We would then need to go 14 days with no new positives to return to no masking if our transmission level is anything other than high.

Visitation is allowed and there is not a limit to the number of visitors a resident can have. We do ask that large groups practice social distancing. Visitors may visit in common spaces, not limited to only the resident's room.

We are excited for these changes and are looking forward to seeing more people in the building, residents enjoying time with friends and family, eating together in the dining room and enjoying group activities.

The Note-ables came to play some toetappin' accordion music for the residents! **Flu season is upon us once again.** The Centers for Disease Control and Prevention states several groups are at increased risk for complications with one such group being nursing homes residents. To lessen the impact of this infection, the influenza vaccine is recommended as the primary way of preventing the illness and its complications. Many studies have shown that vaccination of nursing home residents and staff can significantly decrease rates of hospitalization, pneumonia, and related mortality. The flu vaccine clinic for residents will be on October 18. We will be contacting families and residents regarding who would like to have the flu vaccine.

The FDA and CDC have approved a new bivalent COVID-19 booster, which contains a new formula to provide protection against the omicron variant, which is the current virus strain

circulating across the U.S. Everyone ages 12 and older are now recommended to receive a single bivalent COVID-19 booster. Families and residents are encouraged to look up information on this vaccine as we will be contacting families and residents regarding who would like to receive this booster.
